## **SOFA** explained:


- SOFA is a mutual agreement between the governments of Japan and the United States
- Japanese and U.S. authorities have equal and assured access, regardless of where the individual is held
- Military and Japanese lawyers work together whenever an issue arises
- The differences between the US and Japan legal systems are respected
- Justice is preserved regardless of location or specifics of crimes
- U.S. punishments are generally harsher than Japanese punishments

## Uniform Code of Military Justice (UCMJ):

- U.S. service members voluntarily give up certain civil rights when joining the military
- Military members agree to live under a stricter code and agree to be held to a higher standard
- U.S. service members do not lose their constitutional right to due process by joining the military
- The military justice system is a command-driven system, with the commander acting as the ultimate decision-maker on how to handle misconduct
- To ensure good order and discipline, the UCMJ may punish conduct that other legal systems do not
- Much like the U.S. justice system, The UCMJ upholds the rights of both the victim and the accused
- Service members understand the need for good order and discipline, and are the first to be disappointed and impacted when one of their own does something to discredit the service.
